### Robert Wood Johnson Foundation Grants Aim to Help Shape Difficult Public Health Funding and Service Decisions

#### Have a J.D. and M.P.H. Degree?

Ten years ago, the dual J.D./M.P.H. degree was almost nonexistent. Today, there are 25 accredited programs in the U.S., and that number is growing. A dual degree can save a student both time and money while pursuing a comprehensive education. But the question is: How does having both a J.D. and an M.P.H. degree affect one's professional career? Currently, there is not a lot of data. #### National Health Policy Conference Examines Public Health Under Reform

At the National Health Policy Conference on Feb. 13-14 in Washington D.C., discussion focused heavily on health reform implementation issues, including several sessions devoted specifically to public health services and systems and their roles in reform. A session that examined the implications of the Affordable Care Act for public health included remarks from Arkansas State Health Officer Dr. Paul Halverson, Public Health Practice Based Research Network National Advisory Committee member. Halverson commented that post-reform health departments may look very different from the public health agencies of today, but will likely continue to serve as "gap fillers" in assuring that the health care and public health needs of vulnerable and underserved populations are met. Halverson noted the need for health departments to assume expanded roles in information production and dissemination to guide the larger health system toward solutions that improve population health and reduce system costs. Texas BlueCross BlueShield official Dr. Eduardo Sanchez mentioned the need for more applied PHSSR studies that examine the health and economic value of investments in public health strategies, citing RWJF-funded research studies as examples.

Organized by AcademyHealth's Public Health Systems Research Interest Group, a meeting on the second day of the conference focused squarely on PHSSR and its potential to inform policy decisions in the context of health reform. As part of this meeting, Dr. Paul Wallace of the Lewin Group discussed opportunities for realizing greater synergy between the public health and primary care components of the health system by focusing on the shared goal of population health improvement. The Public Health PBRN Coordinating Center's Dr. Glen Mays profiled various approaches for estimating the value of public health systems and services, and highlighted studies underway within the PBRNs to examine the impact of economic shocks on public health service delivery. The resulting discussion underscored the fact that the PHSSR community is in the midst of unprecedented opportunity to prove its value in informing policy decision-making concerning the current and potential roles of public health in health system reform.

#### Missouri PBRN Examines Association between Voluntary Accreditation on QI Culture

In a recent comparative, mixed-method Quick Strike project, the Missouri Public Health PBRN Affiliate studied QI culture and practices among local health departments in Missouri that have undergone or refrained from participating in that state's voluntary accreditation program to date. The study's qualitative findings revealed that accredited agencies surpassed their non-accredited counterparts in some important elements of integrating QI into routine practice. However, the study's quantitative findings failed to find statistically significant differences between accredited and non-accredited agencies on available measures of QI implementation. The research calls attention to the need for more sensitive and specific measures of QI practice that can be used to evaluate the impact of accreditation and other system-level innovations.
