Then she talked about the "why of PHSSR," a refrain from her note in the April issue of Inside Track. [Harvey Fineberg](#) was wonderful talking about what's next, not only at the Institute of Medicine, but also in the nation, in public health. He was stellar and demonstrated his old professorial ways when he was still talking with students in the banquet room at 11 p.m. after his talk, one of the reasons that I love the man.

[Carol Moehrle](#) was spectacular, demonstrating a practitioner from a small community in Idaho who gets it and can lead the PHAB accreditation board as it goes about awarding its first accreditation, scheduled for this fall. She is a delight and her exuberance is infectious. And [Rich Umbdenstock](#), the CEO of the American Hospital Association, admitted that while he didn't know public health, he knew that hospitals and public health must begin to work closely together in a new normal, with a paradigm change from paying for piecemeal sickness care to payments based on maintaining the health of

sickness care to payments based on maintaining the health of populations. He called for an epidemic of health and said that hospitals were prepared to work with health departments, in fact, must work with them in order to achieve that. Bobby Pestronk of NACCHO and Paul Jarris of ASTHO agreed and grasped the extended hand of the AHA with a commitment to work collaboratively to achieve common goals. [Tom Frieden](#) was our closing plenary, with his message of how we must address the “winnable battles” in public health and the role of research and PHSSR in achieving those wins.

All observed that the the papers presented at this year’s [Keeneland Conference](#) were much more science driven and that the caliber of the research has progressively improved since the first [Keeneland Conference](#). The abstracts we received this year made us more selective in the ones chosen for presentation, which we think made the conference more rigorous. The networking was incredible. At least one group of people participating in a dine-a-round agreed to write a paper for publication together! The World Café we had for new grantees was absolutely a knock-out success, with ideas practically flying around the room. And the [final session](#), led by Ross Brownson and Paul Erwin, featured a horse racing theme in which attendees bet on examples practitioners and researchers working together on a question. The session was a raging success as we demonstrated that we can indeed connect research and practice to benefit the community. I don’t know who the big winner was at the track on Thursday, our closing day, but I do know that it wasn’t me! Remember to mark your calendar for next year (April 8-11, 2013). It will be hard to beat this year’s effort, but we’ll give it a try!

New Online Journal Accelerates Public Health Research to Practice and Policy

An innovative new online journal is providing a platform for quickly putting research on the effective delivery of public health services into the hands of practitioners, policy officials and scholars, aiming to accelerate improvements in public health. [Frontiers in Public Health Services and Systems Research](#) (www.frontiersinphssr.org) is an open access, peer-reviewed journal that aims to shorten the turnaround time between research results and publication of a traditional journal. Frontiers is produced monthly through a collaboration of the Public Health Practice-Based Research Networks (PBRN) National Coordinating Center and the National Coordinating Center for Public Health Services and Systems Research (PHSSR). Both Robert Wood Johnson Foundation-funded centers are based at the University of Kentucky College of Public Health.

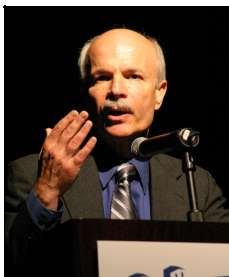

New Publication: At the Keeneland Conference last month, AcademyHealth released a new publication, HSRProj Update: Public Health Services and Systems Research. HSRProj is the National Library of Medicine's free online resource that provides access to recently funded health services research projects and provides a unique opportunity for the research community to view the range of research topics currently being explored, including PHSSR. The goals of this brief were to:

- demonstrate the potential use of HSRProj to identify PHSSR;
- share search strategies for PHSSR, based on the published PHSSR definitions and the search terms used by the National Coordinating Center for PHSSR;
- identify a reasonable range of studies that may be PHSSR; and
- describe results for a subset of projects in HSRProj that are explicitly defined as PHSSR, including key funders and funding trends over time.
