Glen P. Mays, PhD, MPH, is the Director of the [National Center for Public Health Services and Systems Research](#) and the [Public Health Practice-Based Research Networks \(PBRN\) Program](#), and is the Scutchfield Endowed Professor at the University of Kentucky College of Public Health. Dr. Mays' research focuses on strategies for organizing and financing public health services, preventive care, and chronic disease management for underserved populations. A graduate of Brown University, Dr. Mays earned a PhD and MPH in health policy and administration from the University of North Carolina-Chapel Hill, and completed a postdoctoral fellowship at Harvard Medical School's Department of Health Care Policy. Prior to joining UK, he held a faculty position at the University of Arkansas for Medical Sciences, and he was a senior health policy researcher at Mathematica Policy Research. glen.mays@uky.edu
