2008

In 2008, nonprofit hospitals and LHDs were called upon to collaborate with community partners to conduct community health needs assessments, select 2-3 health priorities to focus on, and identify opportunities for action that the local health departments and hospitals could pursue, either individually or in partnership, to alleviate the priority public health problems.



New guidance asks that LHDs and hospitals complete a collaborative community health assessment <u>and</u> explicitly mentions the need for a community health improvement plan.

2012

Requirement for a community health improvement plan is consistent with the recent Public Health Accreditation Board recommendations for LHD accreditation.

2012

Language in New York's guidance for community health planning sent to its hospitals was comparable with the new IRS requirements established under the Affordable Care Act.

What organizational and structural characteristics of a local health department-hospital collaboration are associated with collective impact and the collaboration's capacity for sustainability?

COMMUNITY HEALTH PARTNERSHIPS

Key Characteristics

- Collaborations between diverse organizations and members with wide range of resources
- Focus on problems that cannot be solved independently
- Variety of functions:
 - Information exchange
 - Public health service delivery
 - System and policy level changes
- Centrality: Level of influence one organization has in partnership
- Breadth: Level of diversity in partnership
- Density: Level of interconnectedness between members

COMMUNITY HEALTH PARTNERSHIPS

Determinants of Success

- Common vision/mission
 - Shared goals/objectives
- Partner diversity
 - Homogeneous vs. heterogeneous
- Strong leadership
- Frequent communication
- External funding

- Use of framework or logic model for planning
- Use of evidence-based strategies
- Adaptability
- Clear roles and guidelines for participation
- Supportive organizational climate and culture

SUSTAINABILITY

In 2011, Schierer and Dearing proposed an agenda for research on the sustainability of public health programs:

- Definition and types
- Specifications
- Measurement
- Determinants
- Research designs

Most research has focused on sustainability of programs. Less is known about collaborations.

PHASE TWO: STATUS OF COLLABORATIONS

- Describe current status of collaborations.
- Describe <u>variation</u> in organizational and structural factors linked with conducting CHA and CHIP development.
- Identify <u>associations</u> between organizational and structural factors, and selected outputs.



Retrospective cohort study of 58 LHDs and 148 nonprofit hospitals from 2008-2013 to assess:


- Completion of CHA
- Development of health improvement plan.
- Plan for sustaining community engagement.

CONCLUSIONS

- Percent of CHA-CHIPs in New York containing the recommended elements ranged from 21-74 percent.
- Number of partners varied considerably.
- Plan for sustaining engagement of partners described in only 21-28 percent of plans.
- Nationally, in 2013, 44.5% of LHDs were collaborating with hospitals.
- In 2013, CHA completion was significantly greater in LHDs when the top executive had a masters or doctoral degree.

PHASETHREE

- Develop new measurement tool for assessing collaboration sustainability.
- Conduct case study in four counties to gain insights about factors related to collaboration sustainability, building off the literature review.
- The Program Sustainability Assessment Tool, developed by Douglas Luke, PhD, will be modified to reflect the collaboration component.

CRITERIA FOR SELECTING COUNTIES?

Option #1:

Pick two counties that show a high capacity for sustainability (based on factors from the literature review) and two with low capacity for sustainability.

CRITERIA FOR SELECTING COUNTIES?

Option #2:

Pick four that have excellent structures in place and a diverse partnership and/or are broadly representative of NYS counties.

QUESTIONS

What makes a collaboration distinct from a program?

What are the factors that contribute to its success and keep it going? That get in the way?

Conduct focus groups to solicit input about measuring sustainability	Feedback used to make further modifications.		
Pilot instrument in four counties	Test the adapted tool again.		
Assess instrument for acceptability and internal reliability	Prepare journal article & explore other avenues of dissemination
