#### **Notable Activities**

- ▶ PBRN Webinar to Feature QI Authority. On Wednesday, February 17 from 2:00 to 3:30 pm ET, the PBRN Quarterly Webinar will host Bill Riley, Associate Professor of Health Policy & Management and Associate Dean of the School of Public Health at the University of Minnesota. Riley will discuss the design of research studies to test the impact of quality improvement (QI) interventions in public health practice settings using examples from his own research. Widely recognized for his expertise in public health QI research, Riley is Project Manager for RWJF's Public Health Practice: Evaluating the Impact of Quality Improvement program. Among Riley's most recent publications is the current QI research-focused issue of Journal of Public Health Management and Practice for which he served as guest editor and an author. - ▶ Round I Evaluation Activity. The social network analysis process being used to track changes in the structure and function over time of the program's PBRNs has moved into the pilot testing phase. Members of Hometown Health groups in Arkansas, county and regional collaboratives with comparable network structures to PBRNs, are completing the web-based questionnaire and will participate in telephone interviews early next week to discuss their experiences with the survey. Along with pilot testing and related analysis are the following dates/events:

▶ Research Implementation Awards (RIA). Supplemental funding awards for Round I large research projects are scheduled to begin February 15. Note deadlines for submitting the signed Letter of Agreement, as well as the other details specified for timely funding.

Reminder to Round I Grantees: Remember that RIAs are not official until Foundation award letters are in hand. NCC and grantees will work together with our program communication officer to announce the awards at the appropriate time. Local news releases must have Foundation approval and should not precede the Foundation's announcement.

- → The Results are In! More than 900 people from 48 states and the District of Columbia voted in the Robert Wood Johnson Foundation's Year in Research polling for the top articles in Foundation-funded health services research of 2009. Among those selected as the five most influential research articles is the work of Glen Mays and Sharla Smith (National Coordinating Center) that examined geographic variation in public health spending. The Foundation invites discussion of the themes and articles chosen and not chosen using their Health Reform Blog. Deemed most influential are:
  - Health Care and Public Service Use and Costs Before and After Provision of Housing for Chronically Homeless Persons with Severe Alcohol Problems;
  - What Newly Licensed Registered Nurses Have to Say About Their First Experiences;
  - A Closer Look at the Economic Argument for Disease Prevention;
  - Association Between School Food Environment and Practices and Body Mass Index of U.S. Public School Children; and
  - Geographic Variation in Public Health Spending.

#### **Activities on the Horizon**

▶ PBRN Annual Grantee and NAC Meetings. The excitement is building for the first assembly of all twelve networks! Plans are underway for making the most of our time together at the Annual Grantee Meeting, and we want your input as the agenda is developed.

Guidelines for making travel arrangements will be distributed in the next few days, including use of the RWJF designated travel agent. Please wait to make your flight arrangements until you receive these instructions.

Both cohorts of networks will present at the Keeneland Conference. NCC will schedule conference calls to assist with planning and coordinating these presentations.

- **2010 Public Health Preparedness Summit** February 18 in Atlanta. Mary Davis will present results from the **North Carolina PBRN** study that helped public health practices prepare for last fall's wave of H1N1 flu. The study was supported by the RWJF Quick Strike Research Fund (QSRF) for PBRNs. <u>Link to conference information</u>.
- ▶ Wisconsin PBRN Kick-Off Meeting Friday, February 26. Presenting by teleconference, Glen Mays will open the meeting with an overview of the national program and the importance of practice-based research in public health.
- ▶ National Emergency Management Summit March 3. Research findings shared at APHA generated such interest that Mays and Angela Dearinger (KY PBRN) will present again at this conference in DC, also accessible online (conference information). Kentucky's study of lessons learned from communication among public health and other health professionals during the H1N1 outbreak of spring 2009 also was supported by the RWJF Quick Strike Research Fund (QSRF).

- **Texas Public Health Association** − April 21, 2010. Mays will give a teleconference presentation on practice-based research.
- → Ohio Combined Public Health Conference May 12, 2010. Glen Mays will lead a session on the development and future of public health PBRNs at this annual meeting of the state's public health professionals' organizations. The Ohio PBRN will take advantage of this opportunity to showcase practice-based research and continue developing statewide participation in the network.

#### **CONFERENCES**

▶ Public Health Emergency Legal Preparedness. NACCHO, ASTHO and CDC are co-sponsoring the one-day workshop "High-Priority Tools for Public Health Emergency Legal Preparedness," on February 16 to coincide with the 2010 annual Public Health Preparedness Summit in Atlanta. Public health practitioners will discover ways "to improve use of their public health laws to address influenza outbreaks and other, all-hazards public health emergencies." - NIH Conference on the Science of Dissemination and Implementation: Methods and Measurement will be in Bethesda, MD on March 15-16, 2010. Conference Registration Deadline: February 12, 2010.
- → Community-Campus Partnerships for Health (CCPH). The CCPH annual conference will be May 12-15, 2010 in Portland, Oregon. #### **COURSES**

- → Methods Courses. Plan to enhance your methodological toolkit in March by participating in a live webinar series on methods for public health research. - ▶ Using Public Health Data. If members of your network use or would like to use public health data in their professional decision-making but may not have taken related training courses, a seven-week, online mentored course is available. "Demystifying Data: Accessing, Using, and Interpreting Data in Public Health" is scheduled from February 22 through April 11, 2010, for a fee of \$135. #### **NEW LITERATURE**

- **▶ Evidence-Based Public Health Interventions**. The *Guide to Community Preventive Services*, a resource for evidence-based public health research, has been updated with recent findings related to worksite health promotion interventions.

  Screening for Obesity in Children and Adolescents. In the last issue, we reported publication of US Preventive Services Task Force's revised recommendations and related evidence for clinicians screening children for obesity in the February <a href="Pediatrics">Pediatrics</a>, at <a href="AHRQ's website">AHRQ's website</a>, and in the <a href="Guide to Clinical Preventive Services">Guide to Clinical Preventive Services</a>. Public Health PBRNs that partner with primary care PBRNs or community providers may be especially interested in the findings released a few days later of two RWJF-sponsored studies examining best practices for encouraging primary care physicians to screen and treat childhood obesity. In addition to their results that also are published in <a href="Pediatrics">Pediatrics</a>, the researchers enhanced the American Academy of Pediatrics' <a href="website">website</a> with useful information for health professionals, families and communities, including state-specific policies and projects.
  - → State-level School Policy and Youth Obesity. In the January 2010 issue of *American Journal of Preventive Medicine*, Nanney and colleagues examine linkages between states' school obesity prevention policies and youth obesity. The article is available free.

#### **PUBLICATIONS**

- → The 2009 Influenza Pandemic: Selected Legal Issues. The Congress Research Service (CRS) has released a Report for Congress summarizing various legal issues related to the H1N1 Influenza outbreak. Many of these matters also may interest public health practitioners and researchers. View the report <a href="here">here</a>.
- → The National Health Security Strategy. HHS Secretary Kathleen Sebelius recently released the nation's first comprehensive strategy for protecting people's health during a major health incident. Read the report to see what constitutes a "health incident" and how the strategy will be applied.

▶ PHAB Seeks Input. During the beta test of the public health accreditation program, PHAB will seek health department feedback into various documents and processes. Three documents are open for review at the PHAB web site linked here.

### **Funding Opportunities**

Prevention Research Center Funding. PBRNs with PRC partners will be especially interested in CDC's PRC funding "to support comparative effectiveness research on innovative public health strategies or interventions that assess the impact of policy and environmental interventions." Applicant eligibility is limited to existing CDC PRCs (see announcement.)

Examples of innovation include (but are not limited to) adaptations of established health promotion or disease prevention interventions that have not previously been tested; testing of strategies or interventions in settings or populations (such as minorities or people with disabilities) that have not previously been the target for such interventions; testing novel combinations of adapted interventions; or testing traditional and nontraditional research designs (e.g., comparison of unplanned natural experiments using surveillance-based data).

**Key Dates**: Pre-application Webcast February 17, 2010, from 3:00pm – 5:00pm EST

Letters of Intent are required and due February 22, 2010.

Applications due on or March 22, 2010.

- ▶ **RWJF** *Public Health Law Research* (**PHLR**). PHLR will issue its second CFP on February 10. Get the details on the program web site.
- ◆ Obesity Prevention Research. RWJF's Active Living Research (ALR) program has released calls for proposals aimed at preventing obesity in children and youth through policy and environmental strategies that increase physical activity and decrease sedentary behaviors. This round emphasizes strategies to reach children at greatest risk for obesity and those living in lower-income and underresourced communities. New Connections grants, administered by the ALR program, are a part of the CFP. Details linked here.
- ▶ Pfizer Fellowships in Public Health Research. Pfizer offers career development awards for junior faculty pursuing careers in public health systems and services research. Research collaboration with state and/or local public health agencies is required. The 2010 announcement is available online, and the application deadline is February 12, 2010. Glen Mays is on the academic advisory board for this fellowship and can answer questions.

- ➤ Community Action for A Renewed Environment Program (CARE). The EPA has issued a RFP for its CARE program. Read the <u>full announcement</u> to note the two types of efforts supported, the atypical application processes, and the entities eligible to apply for this highly competitive funding. Deadline for application: March 9, 2010.
