# **Notable PBRN Activities**

- ◆ PBRN Public Health Activities and Services Tracking (PHAST) Study. PH PBRN participants formally launched the PHAST study on October 22 in Little Rock. Twenty-two participants from 11 PBRN states laid groundwork for the goals, processes and next steps of the study. To facilitate conversation among colleagues in networks discussing involvement in the PHAST study, the presentation slides, a meeting summary, and *The Science of Producing Public Health Services* paper can be accessed via Google Docs.
- Grant Awarded for Health Impact Assessment. Among the grants announced recently by the Health Impact Project to study health implications of policy proposals was an award to Green River District Health Department in Owensboro, Kentucky, a participant in the Kentucky Public Health PBRN. According to the news release, the study "is the first to address the overall health impacts that may result from a coal gasification project," three proposed plants that could affect the health of up to 500,000 people. Study results will be available in time to inform policymakers' decisions on the plants in the spring of 2011. The Health Impact Project is a collaboration of the Robert Wood Johnson Foundation and The Pew Charitable Trusts.

## **REPORTS AND PUBLICATIONS**

- Community Guide EBP Updates. The Guide to Community Preventive Services has been updated to reflect the most recent findings and conclusions of the Task Force on Community Preventive Services. Updates are available in the <u>Vaccines to Prevent Diseases</u> and the <u>Cancer Prevention</u> and <u>Control: Client Oriented Screening Interventions</u> sections.
- PHSSR and Health Reform. <u>HCFO's October e-newsletter</u> features Public Health Services and Systems Research (PHSSR) as its "hot topic." The discussion highlights how several features of the new law will channel funding toward prevention and public health research. Several exemplary studies funded by HCFO are highlighted.

### NEW TOOLS

- CDC's New Social Media Toolkit. Integrating social media into public health activities, communication, and dissemination can be effective ways for the expansion of reach, encouragement of engagement, and increase access to evidence-based public health research. - NASHP launches State Refor(u)m. The NASHP State Refor(u)m website is a hub for statedeveloped resources related to national health reform implementation. It is designed to support state officials working to implement health reform.

#### **CONFERENCES AND WORKSHOPS**

- Comparative Effectiveness Research Methods Conference. The National Institutes of Health (NIH) and Agency for Healthcare Research and Quality (AHRQ) are co-sponsoring "Methodological Challenges in Comparative Effectiveness Research," a conference in which participants will use case studies to examine and address the limitations of existing intervention research. According to the announcement, the meeting is designed to "explore current methodologic, data analytic, infrastructure and database research challenges in order to help develop a vision for shaping the methodological tools of tomorrow." Conference dates are December 2 and 3 on the NIH main campus in Bethesda, Maryland. Registration deadline is November 17. Link to more information, including registration.
- Modeling for Public Health Action. CDC's Preparedness Modeling Unit is hosting the 2010 Conference on Modeling for Public Health Action on December 9 and 10 in Atlanta. According to the announcement, the conference is designed to "promote the exchange of information and ideas about modeling uses to shape public health action. Intended audiences include "public health practitioners and policy makers in state and local health departments, state and local health policy makers; scientists and modelers working at CDC and its federal partners in public health; academic researchers, non-government organizations, and international practitioners, modelers and policy makers." # **New Literature and Exemplary Studies of Interest**

- Public Opinion and Public Health. In the November issue of *Health Affairs*, Robert Blendon and colleagues discuss their examination of multiple data sources for Americans' perceptions of priorities, government spending and system performance in public health. (Interestingly, the term "public health" was not used in any of the questions examined in the study because of previous results showing confusion over its meaning. Citation #2 in article.) The work was supported by RWJF and is linked here at the Foundation's web site.
- Public Health Systems and Partnerships. In an article by Glen Mays and Doug Scutchfield in the November 2010 issue of <u>Preventing Chronic Disease</u>, evidence and uncertainties concerning the use of partnerships to improve the performance of the public health system are examined, with a special focus on partnerships between public health agencies and health care organizations.
